3. HAZARDS IDENTIFICATION

R12 Extremely flammable., R67 Vapours may cause drowsiness and dizziness.

PRESSURISED CONTAINER - increase in temperature to greater than 50C will cause internal pressure to rise

4. FIRST AID MEASURES

5. FIRE FIGHTING MEASURES
